1. Introduction

- c) These Course Terms & Conditions and Disclaimer are relevant to all TINT events, courses or trainings including online and self-paced learning.
- d) For the purposes of these Course Terms & Conditions and Disclaimer, all events, seminars, and courses will hereinafter be referred to as the "**Course.**"
